AUGUST, SEPTEMBER AND OCTOBER BUSINESS NOTES

Boyleston Lodge members met on August 7th and had a fine meal as usual before the business meeting – there were 38 members present, 13 Past Masters, and 1 visitor. Brother Bobby Pittman then read minutes for all the happenings in July (four meetings) ... we should budget for some throat

drops for brother secretary! Capping the month was the Master's degree put on by the Past Master's Club where we had 62 with 10 visitors and 30 Past Masters seated in lodge! We sure had some good work the past couple months ... good job all who helped put it on. We have work again this month, so make your plans to visit Lodge #123 soon!

Brother Lindsey Koon told the brothers 'Thank You' for all the calls, cards, prayers, and visits over the past few months. You see, folks, it DOES work! Our Junior Warden, Brother John Meetze, let everyone know of the specifics of the August Barbecue and solicited help from the craft. The event took place on the weekend of August 9th, and had the makings of a successful fundraiser. Thanks to all the folks who helped with the many chores involved in our fundraiser. Good job with such an awesome responsibility, brother John!

Updating us on the situation with the Lamar billboard on the Boyleston property, brother J.J. Gentry brought everyone 'up to speed' on where we stand. As a refresher, we had a ten year contract with Lamar which began in 1997 at \$100 per month revenue for the billboard. Specific wording in the contract provided for an automatic renewal at the same cost for an additional five years if nothing in writing was provided to cancel the contract. Lamar responded to our inquiry with some offers which would supersede the current contractual terms, including:

- ✓ \$23,600 if they purchased it from us
- ✓ \$1750 per year for a 10 year term
- ✓ \$2000 per year for a 15 year term

J.J.'s recommendation, and the one agreed upon in lodge, was to let the next 4 years proceed as is currently contractually obligated. Then take the appropriate action in the correct allowed time

frame to end the contract as we know it. We would then renegotiate on a year-by-year basis. Big thanks to J.J. for all the time and effort in pursuing this tricky matter!

More 'Thank You Notes' were read in lodge: Christgate Mission sent sincere thanks for the lodge purchasing the needed supplies and toiletries for those being cared for at the mission. Riverland Hills Baptist Church sent a note acknowledging the donation in memory of recently passed bro. Busby. Shortly thereafter, the brothers voted to donate \$150 from the Relief fund to benefit a needy child in the Chapin area. All of this giving brought out some concerns about which funds are to be used for what charities, how to go about giving to widows and orphans in need, and how Grand Lodge treated the same subjects. Someone was going to check w. M.W.B. G. Ray Marsh to see ...

On September 4th, the brothers met again to deal with the business at hand. There were 36 in all, including 16 Past Masters. Supper consisting of stewed tomatoes over rice with ham, butter beans, and cornbread was outstanding. It really hit the spot! There was one petition read, and we voted for one affiliate and one brother to continue and receive his master's degree. A request to have an retail automated ice stand 'facility' placed on lodge property was brought up in lodge but was thought to place the lodge's tax status in jeopardy and was not brought to a vote.

WB David Easley gave a report on the rental of the former Richland building as during the month prior to the business meeting a request to use the building was received by the same folks who used it previously. The committee for caretaking of the building met shortly thereafter and approved the use of the old lodge if all the paperwork and proper insurance requirements were met. An inspection of the HVAC systems was performed as it was not cooling properly. A good bit of work and a lot of money are likely involved in permanently fixing the problem. The brothers also voted to place a for sale sign on the property. The report was accepted by the brethren.

Due to the need for cleanup work around the old Richland building, Worshipful Master Carl Sellers designated the second Thursday as a work day at the former lodge building on Kennerly Rd. There

must have been 20 or more people there to help weed-eat, mow, remove trash from the inside, vacuum, and pretty much give it a good fall cleaning. And it looks a whole lot better. Thanks to all who helped, and to Bro. Ronnie Alcorn and Bro. Jeremy Alcorn who took care of getting in touch with MCEC to have the power pole replaced. It appears to have been hit hard by some vehicle over the past few weeks and was cracked on one side. The new pole is now in and functional.

The building committee also checked on the HVAC unit at Boyleston Lodge as it didn't appear to be working as well as it could have been. The filters in the fan-coil unit were old and not filtering well. They also had holes in them. The result was that the unit's coils are pretty much stopped-up. Getting to them to clean them is a difficult proposition. Bro. Bobby Pittman will be getting hold of someone to take care of the work as soon as he becomes available. He will do a good job and is very reasonably priced.

Prior to getting into Health and Happiness (see the next page), Brother Hal Curtis gave his usual excellent report on how everyone was doing. In addition, he challenged every brother to call up someone who was laid up in bed or unable to get out. Check on them; see if they are doing OK and find out what you can do to help. Invite them to lodge! Calls and cards do wonders for those who can't get out or are recovering from sickness or surgery, or are otherwise unable to get around normally. So call and ask a brother to lodge next month!

Brother Secretary read a thank you note from the Masonic Service Association for the \$170 donation given by the lodge to the Masonic Volunteer Services at Dorn V.A. Hospital. The Oliver Gospel Mission also sent a thank you note for the food that the lodge donated following the last fund raiser. Good job, brothers! Finally, it was decided that the brothers would meet to try out some Bar-b-que at the new Lil' Pigs BBQ located on Broad River Rd. near the Peak Exit (I-26 Exit 97) at the site of the former Whale's Tail restaurant. We met there at 6:30 on Friday, September 26th, and good food was enjoyed by all! (*Next eatin' meetin' is on Oct. 24th*)

35 were there to partake in some mighty fine fish chowder, prepared by Bro. Ronnie Faircloth and W.B. Carl Sellers. After the minutes were read and paperwork was taken care of, Bro. Gene Swygert brought to the brothers' attention the condition of the HVAC unit and motioned that we purchase a new one. After some discussion and amending of motions, it was decided that a qualified HVAC service man would check it out thoroughly and if needed, we would pursue replacement. The motion passed.

Bro. Junior Warden reported on the success of the last Bar-b-que: we spent \$3,980 but grossed \$6,782 for a profit of \$2,802 ... nice work Brother Trey - (and good work in the East the following week for the EA Degree)!

The committee on the former Richland Building gave an update on the status of the site. At least twenty folks have been buy or called and inquired about the facility and property. It has been shown at least three or four times, and we've had some offers. Stay tuned, because if we get a good offer and it turns out to be workable for the new owner and ourselves, **we will have to vote as a lodge to approve the sale.** You will be informed in this newsletter ... and it will be sent to ALL Lodge Members. It will likely be the headline story that month. Thanks so much to Bro. Gene Swygert for so often making himself available to help us move on that property.

A letter from the Grand Treasurer arrived at our lodge and informed us that we have earned \$92.69 on the few Perpetual Life Memberships purchased under Boyleston Lodge #123. MWB Jack Marler's comments also included a challenge that we have at least two more purchase these memberships before April of next year. For your convenience, we have enclosed the scales used to calculate how much a Perpetual Life Membership would cost you (from Ahiman Rezon 2003, p.354 within section 15(g) of the Code):

Age	Factor
21-29	25
30-39	23
40-49	20
50-59	18
60-64	15
65+	10

To figure out how much one would cost you, find the factor which matches your age group and multiply by our annual dues rate: A forty-two year old would pay by a factor of 20 ... hence 20 times \$45 for a total cost of \$900. Again, it is based on the dues charged for the year, so if that changes to \$50 in the future, then so does the one-time cost. Forms are available online at www.sgrandlodgeafm.org.

A good bit of discussion came about when W.B. Ray Boland brought up the fact that the property adjoining our lodge to the north/west between CVS and our parking area is for sale. We as a lodge may want to consider making that purchase at some point. More information is to be gathered on this, and will be put out there at the next available time!

Brother Hal Curtis gave his usual outstanding report on health and happiness (see details a little further down), and fired up the brothers to look into doing a good fall cleanup of the Boyleston property. Stay tuned for work day information. Bro. Hal also mentioned that RWB Joe McGee did a fine job conducting a Masonic service for the late Bro. Aubrey Addy. Hal passed around a real true sprig of acacia for everyone to see. Thanks, Bro. Hal!

All in all, it was a great meeting. Make it a point to come on out to YOUR lodge in the upcoming months.
